**A RESOLUTION OF THE TOWNSHIP OF LIBERTY, CENTRE COUNTY,  
PENNSYLVANIA, AS TO THE IMPOSITION OF A UNIFORM ASSESSMENT  
UPON PROPERTIES WITHIN THE TOWNSHIP BENEFITED BY PUBLIC  
LIGHTING.**

WHEREAS, Article XX of the Second Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. § 67001 et. seq., grants to the Board of Supervisors of Second Class Townships the power to light and illuminate the highways, roads and other public places of the Township and to pay for the costs of public lighting by various prescribed methodologies; and

WHEREAS, the Board of Supervisors of Liberty Township, Centre County, Pennsylvania, previously adopted a Resolution imposing the cost of the Township's public lighting through a uniform annual assessment upon benefited properties on the foot-front basis; and

WHEREAS, the Board of Supervisors desire to generate additional revenues for the cost of said public lighting and desire to adopt a more equitable assessment upon each property benefited; and

WHEREAS, Section 67003(a)(3) permits the Board of Supervisors to pay for the cost of public lighting by a uniform annual assessment upon each property benefited.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the Township of Liberty, Centre County, Pennsylvania, as follows:

1. Revocation of Foot-Front Assessments.

The Board of Supervisors of Liberty Township, Centre County, Pennsylvania, hereby revoke and repeal any and all previous assessments made by the Township of
