## ORDINANCE 21

### Public Notice

Notice is hereby given that the Supervisors of Liberty Township, Centre County, Pennsylvania, will consider for passage the following Ordinance at their meeting to be held Wednesday December 2, 1987 at 7:00 PM at the Liberty Township Municipal Building.

AN ORDINANCE OF LIBERTY TOWNSHIP, CENTRE COUNTY, PENNSYLVANIA, PROVIDING FOR THE COMPENSATION OF SUPERVISORS OF LIBERTY TOWNSHIP ON A PER MEETING BASIS.

BE IT HEREBY enacted and ordained by the Supervisors of Liberty Township, Centre County, Pennsylvania, as follows:

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 68 of 1985 setting forth certain guidelines and limitations for the compensation of Supervisors of Townships of the Second Class, and

WHEREAS, the said Act provides that the Supervisors of Township having a population of up to 4,999 shall be compensated in an amount not to exceed one thousand five hundred (\$1,500.00) dollars per year, and

WHEREAS, the population of Liberty Township, Centre County, Pennsylvania, is under 4,999, and

WHEREAS, the General Assembly by said Act 68 authorized the Boards of Supervisors of the various Townships of the Second Class to determine the compensation of supervisors subject to the limitations set forth in the Act,

NOW THEREFORE, be it hereby enacted and ordained by the Supervisors of Liberty Township as follows:

1. Each Supervisor of Liberty Township elected or appointed to office on or after November 5, 1987 shall receive compensation for attending duly advertised general or special public meetings of the Board of Supervisors at the rate of Seventy Five (\$75.00) dollars for each meeting attended by such Supervisor.
2. Such compensation as aforesaid shall be paid in monthly/quarterly installments.
3. No Supervisor shall receive annual compensation under this Ordinance in excess of the annual statutory limit set by the General Assembly in Act 68 for Supervisors of Townships within the appropriate population category.
4. This Ordinance shall be effective January 1, 1988

The following ordinance is hereby adopted by the Board of Supervisors of  
Liberty Township, Centre County.

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 60 of 1995, setting forth certain guidelines and limitations for the compensation of supervisors of townships of the second class, and

WHEREAS, said act provides that supervisors of townships having a population of 0 to 4999 may be compensated in an amount not to exceed \$1,875.00 per year, and

WHEREAS, the population of Liberty Township is 1739, and

WHEREAS, the General Assembly by said Act 60 authorizes the board of supervisors of the various townships of the second class to determine the compensation of supervisors subject to the limitations set for the in the act,

Now, therefore it is hereby enacted and ordained as follows:

1. Each supervisor of Liberty Township elected or appointed to office on or after the effective date of this ordinance shall receive compensation for attending duly advertised general or special public meetings or hearings of the board of supervisors, or other meetings authorized by the board of supervisors at the rate of \$93.75 for each meeting attended by such supervisor, not to exceed \$1,875.00 per year. (Note: The amount may not exceed the maximum allowed by law based on the population of the township.)
2. Such compensation shall be paid in monthly or quarterly installments.
3. This ordinance shall become effective on January 1, 1996.
