

ORDINANCE # 23
 AN ORDINANCE ESTABLISHING STOP
 INTERSECTIONS FOR LIBERTY TOWNSHIP,
 CENTRE COUNTY, PENNSYLVANIA

THE TOWNSHIP OF LIBERTY hereby ordains as follows:

ITEM I: The following intersections are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second named Street (the intersecting or through Street) on the first named Street (the stop Street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first named or stopped Street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Vehicle Code, and shall not proceed into or across the second named or intersecting or through Street until he/she has followed all applicable requirements of that Section of the Law.
